### **Kent V United States Case**

Case Summary of Kent v. United States: Morris Kent, at age 16, committed several serious crimes. The Juvenile Court, without providing Kent's counsel with important files or allowing a hearing on the issue, decided to waive jurisdiction so Kent could be tried as an adult. Kent's objections to the waiver were denied.
